On 03-30-08 at 1317 hrs, Baltimore City Police Officers were dispatched to the Marriott Hotel located at 110 S. Eutaw St. room number 1060 in reference to a possible triple homicide. Baltimore City Police Communications advised that they had received a call from the hotel staff and they stated that a subject in room 1060 called the front desk and advised he had just killed his children and had attempted to kill himself. Responding Officers were directed to the 10th floor where room 1060 was located. Security used a master pass key to open the door and the officers made entry into the room. Upon entering the room, the officers observed an adult male, later identified as Mark Anthony Castillo M/H DOB: 07-09-66, lying in a bed facing the outside wall. In a second bed, three children identified as 6 year old Anthony Castillo, 4 year old Austin Castillo, and 2 year old Athena Castillo were found lying naked and deceased. Mr. Castillo was placed into handcuffs making the scene safe for the medics to treat him for his injuries. While being treated for his injuries, Mr. Castillo made an unsolicited comment telling the paramedics "I know what I did was bad. I did it. I drown the kids last night around 6:00 pm."

Mr. Castillo was subsequently transported to University of Maryland Shock Trauma where he underwent further treatment for his injuries. While at the hospital, Mr. Castillo continued to make unsolicited statements implicating himself as the sole suspect in this case. Detectives from the Baltimore City Homicide Unit responded to the hospital and advised Mr. Castillo of his rights per Miranda. Mr. Castillo understood and waived his rights and consented to a taped statement. Mr. Castillo gave a full confession to the murder of his three

children providing a motive based upon a recent divorce stemming from domestic issues with his wife Amy Castillo. Mr. Castillo went on to say that he drowned his kids in the bathtub one at a time, and then placed them in bed. Once he had killed all of his children, Mr. Castillo stated he attempted to commit suicide by stabbing himself in the neck several times with a steak knife. Additionally, Mr. Castillo advised he consumed upwards of 100 Motrin pills to further his success in his suicide attempt. Mr. Castillo then advised he fell asleep. Mr. Castillo went on to say that he awoke at 1:00 pm realizing he was unsuccessful in committing suicide. Mr. Castillo then notified the hotel staff from a telephone in his room, which initiated the police and fire response.

Based upon the above investigation, your affiant, Detective Robert Ross of the Baltimore City Police Department Homicide Unit, prays that an arrest warrant be issued for Mark Castillo M/H DOB: 07-09-66, charging him with Murder in the First Degree. All events occurred in Baltimore City Maryland.
